The Mayor invited nominations for the Castle ward vacancy, and Councillor M. Perfect nominated Mrs. D. Jones, with Councillor V. Perfect seconding the nomination.

The Mayor then invited nominations for the Coleshill ward vacancy, and Councillor M. Perfect nominated Mrs. M. Hanson, with Councillor N. Davies seconding the nomination.

RESOLVED: That Mrs. D. Jones be co-opted as a Town Councillor for the Castle ward and that Mrs. M. Hanson be co-opted as a Town Councillor for the Coleshill Ward and that the Town Clerk will inform all candidates of the decisions made.
